## **Overview of the agenda of the ECOFIN Council**

The Council will hold an exchange of views on the possible introduction in the EU of a levy on banks, as well as a tax on financial transactions.

It will also take stock of changes in implementation of the stability and growth pact in order to allow for the establishment as from 2011 of a "European semester", during which the budgetary and structural policies of the member states would be monitored.

The European Council will discuss, in the presence of foreign ministers, the EU's relations with its strategic partners, in particular with emerging countries in Asia, in the context of bilateral summits that will be held in the autumn, as well as the forthcoming G20 summit in Seoul, in November.
